MOTION OF APPELLANT CITY OF PHILADELPHIA TO SUPPLEMENT THE RECORD

Appellant, the City of Philadelphia (City) Police Department, by a through its undersigned counsel, hereby moves to supplement the record in the above captioned appeal as follows:

1. In the instant matter, the City has appealed the December 3, 2021 Final Determination of the Office of Open Records (OOR) in *Lownes v. City of Philadelphia, Mayor's Office*, OOR Dkt. AP 2019-1981 granting, in large part, Appellee Mr. Lownes' (Appellee) appeal seeking "all submitted Board of Education 'interest forms' submitted by individuals applying to be Board of Education appointees between the dates of 9/1/2020 and 12/8/2020)" (the Request). The City refers to these forms, which include cover letters, resumes and curriculum vitaes as "Statements of Interest" or more generally as applications.

- 3. At issue is the identities, resumes, curriculum vitaes, financial information, and very personal statements of dozens of private residents of Philadelphia who applied, unsuccessfully, to volunteer for the Board of Education.
- 4. The request for these sensitive records were a matter of first impression for the City as well as OOR and implicate novel issues of law.
- 5. Additionally, the Request came in and was appealed during the midst of the COVID-19 pandemic and at a time when the City was particularly short staffed, as described in the Affidavit of Feige Grundman, Divisional Deputy City Solicitor of the Law Department's Right to Know Division in her affidavit that is part of the Supplemental Record the City seeks to file. Exhibit A, S.R. at 035, at ¶ 13.
- 6. Ms. Grundman further explains that the hopeful volunteers whose records were at issue were confused about the process of participating in the OOR appeal and many that indicated they wanted to participate did not end up submitting the proper paperwork. Exhibit A, S.R. at 034-35, at ¶¶ 02-14.
- 7. The OOR's Final Determination recognized the confusion experienced by the applicants but nevertheless ordered the disclosure of their personal information with limited redactions. Certified Record, *Philadelphia v. Lownes*, No. 220100090, Phila. CCP (Filed May 2, 2022 by OOR) (C.R.) at 199-201, 212.
- 8. On January 3, 2022, the City timely filed the instant appeal of the OOR's Final Determination.
- 10. The Supreme Court of Pennsylvania has held that courts hearing appeals from the OOR "have the authority to expand their record to fulfil their statutory role" as fact finders. *Bowling v. Office of Open Records*, 75 A.3d 453, 476 (Pa. 2013).

- 11. Moreover, the Commonwealth Court has specifically and repeatedly held that agencies may meet their burden of proof in Right-to-Know matters through the submission of affidavits. *See, e.g., Hodges v. Pa. Dep't of Health,* 29 A.3d 1190, 1192 (Pa. Commw. 2011) ("[A]n agency may satisfy its burden of proof that it does not possess a requested record with either an unsworn attestation by the person who searched for the record or a sworn affidavit of nonexistence of the record.").
- 12. At issue in the instant appeal is whether the OOR improperly held that the detailed biographical and professional profiles of dozens of private Philadelphia residents who sought to volunteer for the City are subject to public disclosure.
- 13. As third-party interests are involved, supplementation of the record is particularly appropriate. *Cf. Pennsylvania State Police v. Grove*, 119 A.3d 1102, 1110 (Pa. Commw. Ct. 2015), *aff'd in part, rev'd in part on other grounds*, 161 A.3d 877 (2017) (holding that ground of denial was properly raised for the first time on appeal to Commonwealth Court because "[a]n agency . . . cannot waive third parties' privacy rights").
- 14. Additionally, in the course of the instant appeal, the City disclosed the Statements of Interest of those candidates that were ultimately appointed to the Board, as a result a portion of the appeal is now moot. Exhibit A, S.R. 001-030.
- 14. The City's supplementation of the record would allow the City clarify the public interest in maintaining the confidentiality of unsuccessful applicants' to the volunteer role on Board of Education, better contextualize the outreach process to unsuccessful applicants and concerns such applicants raised in the process, and provide information on the records that were released while this appeal was pending.

16. For the reasons discussed above, supplementation of the record is necessary to clarify the factual issues related to the privacy of dozens of Philadelphian residents whose records are at issue in this appeal and relate directly to the arguments raised by the City in its brief.

WHEREFORE, for the foregoing reasons, City respectfully requests that the Court grant its Motion to Supplement the Record with the supplemental affidavit attached as Exhibit A.

I am an attorney in the Law Department who used to work on RTK matters but transferred out of the RTK Division a few years ago. Because of extreme staffing shortages in the RTK Division, and in an effort to move the matter forward, I will be working on the above captioned appeal. I write on two matters with respect to the above captioned appeal:

First, attached please find the applications of those nominees for the Board of Education who were selected and currently serve on the Board of Education, redacted in accordance with the OOR Determination issued in this matter. After further internal review and consultation with the members, the City has determined that it is appropriate to release the redacted applications of these successful applicants.

Second, I'm writing to let you know that the City will need to seek an extension to file its brief in this matter concerning the public nature of applications of unsuccessful applicants. The City continues to assert that these records, reflecting the personnel information of private City residents, are exempt from disclosure under applicable law. Unfortunately, since the City last sought an extension, the RTK Division has lost yet another attorney and the Law Department in general is struggling with significant turnover and short staffing. I am stepping in to assist given my prior involvement in this area of law but I also have significant other responsibilities outside of RTK matters and need time to get up to speed on the case. I will be seeking a 30-day extension. Please advise if you will agree to this extension, if you intend to oppose it, or if a discussion would be helpful.

I also would bring the value of being an attorney who is must read and distill large quantities of information in a way that is readily accessible to others. I also bring experience in community engagement and service.

I have reviewed the Goals and Guardrails, and at the outset I would use them as the fountainhead from which all of my actions as a member of the Board would flow.

Secondly, I would seek out experts amongst the many legal and educational experts that I know so that I would be utterly equipped to join, guide and lead discussions around the importance of all students in Philadelphia either reading at or above their grade level, excel in math--as it is the foundation not just education in STEM, but to all professions, and the importance of getting students to think and believe that they can succeed post-secondary school toward college and vocational spaces.

Third, understanding that schools must be safe spaces for learning and expression. Creating safe spaces for students in public schools creates fertile soil for children to thrive will be something that I would intentionally collaborate with fellow Board members to foster. Finally, I would work to with parents, teachers, Board members and other stakeholders to ensure that institutionalized racism is rooted out of the district. Without this, equality of opportunity is not attainable.

All in all, I would strive to continue to educate myself, speak truth to power when necessary, take a keen interest in representing the interests of the parents and most importantly the students.

I know that I have the passion and life experiences necessary to be an excellent board member. I am (1) a product of the Philadelphia public school system, (2) a parent who currently attend a Philadelphia public school, (3) an attorney, and (4) an active member to various non-profit executive boards and other community facing organizations. In sum, I am intentional in staying connected to my community and it has further empowered me to be an effective advocate for them in all the spaces I serve.

I am a product of Philadelphia public school system. I graduated from the neighborhood schools of Leeds Middle School (1997) and the now shuttered Germantown High School (2001). Going to and successfully matriculating through public schools gave me invaluable insight as to the multivariate positive impact that public schools can have on someone such as myself. I am from the northwest portion of city and have spent most of my formative years in Mt. Airy and then in Germantown. Going to Leeds and Germantown High gave me access to an education and social atmosphere that became spring board as to who I am today. Just as many students in the district, I had my difficulties in high school. However, I had an interaction with a teacher at Germantown High School, Mrs. Altman, who challenged me to overcome these barrier and be better, and I can honestly say that her words of tough love helped to propel me to eventually complete my bachelors and Juris Doctorate degrees.

Based on my personal experience in Philadelphia public schools, it was a no-brainer

I decided to send our children to

witnessed first-hand the logistical issues that beset the children, parents, the faculty and the administration of the school before and during the pandemic. All in all, I am passionate about children in Philadelphia to have access to quality education regardless of the school of the zip code they live in.

As an attorney, I have sharpened and cultivated many skills that I believe relate to the work of the Board. I worked for Chief Judge Theodore McKee in the Third Circuit Court of Appeals. In

this position, I sometimes read thousands of pages of case briefs and cases, with a quick turnaround, in order to aid the judge in drafting opinions. What value do you feel your experience would your experience bring to the BOE?

First, I bring over fifteen years of special education advocacy, training, and special education understanding to the Board of Education. This includes understand the needs of those living with disabilities needing special education supports and services, and those struggling learners needing early intervening services such as Response to Intervention and Positive Behavior Intervention Supports. First, I will ensure families and the community are informed on the Board of Education's Goals and Guardrails, so they fully understand what is expected from the school for the child's education. For the goals of Reading, Math, and College and Career Readiness, I would request data on the execution of these goals, especially with struggling learners, special education learners, and English Language learners to ensure these groups of students are not overlooked by the district.

Second, again, ensure families and the community are aware of the four guardrails of Welcoming, Safe and Supportive Schools, Enriching and Well-Rounded School Experiences, Schools Partnering with Parents and Families Members, and Addressing Racist Practices. I would discuss with my fellow Board Members on setting up a hotline and email to collect data separate from the District, to inform our asks of the District for change, as, to my knowledge, this information is not shared with the Board for review. For example, after the adoption of these Goals and Guardrails, I will advocate for the use of some of the \$100 million dollars donated by the University of Pennsylvania towards accessible schools so those living with physical exceptionalities can travel through our schools independently.

Finally, I will work with my fellow board members on increasing positive and meaningful partners between schools and families and charge the district with addressing the racial inequities as testified by many individuals during the previous board meetings.

I am unemployed due to however, these issues are not a barrier to attend meetings, press conferences, school activities, and other events necessary to fulfil this important role.

Even having a has not steered me away from participating in the sometimes-lengthy meetings. However, the discussion from board members on certain issues, or the long list of participants speaking on issues near either near to their heart or pertaining to their children is worth listening via the long hours. Affidavit of Otis Hackney, Chief Education Officer City of Philadelphia

My name is Otis Hackney and, as the Chief Education Officer for the City of Philadelphia, I am authorized to execute this affidavit. I state the following to the best of my knowledge, information, and belief under penalty of perjury pursuant to 18 Pa.C.S. § 4904 relating to unsworn falsification to authorities:

- 1. I have served in the position of Chief Education Officer for the City since January 4, 2016. In this role, I oversee various citywide education initiatives serving thousands of children families in Philadelphia, including being instrumental in the 2017 transition of the School District of Philadelphia's governance back to a locally appointed school board after 17 years of state control. Prior to my role as Chief Education Officer, I served as the Principal of South Philadelphia Highschool.
- 2. I am familiar with the process for seeking applicants to serve as the nine (9) members on the Board of Education for the School District of Philadelphia (the "Board").
- 3. I provide administrative support to the Education Nominating Panel (the "Panel") in their search for candidates to recommend to the Mayor pursuant to the Panel's role under the City of Philadelphia's Home Rule Charter.
- 4. Hopeful volunteers apply to be considered for an unpaid position as Board member by submitting a Statement of Interest to the Panel.
- 5. The position of a Board member is a very demanding role and it requires significant dedication of time without pay. On top of their regular, generally full-time jobs, Board members are expected to:
 - Attend regular monthly meetings

- Public Action Meetings (approximately 4-6 hours during the evening)
- Executive Sessions (approximately 3-4 hours during the daytime)
- o Committee Meetings (approximately 3 hours during the daytime)
- Meet with the Mayor and City Council in Council Chambers to discuss the administration, management, operations, and finances of the School District (at least twice per school year)
- Attend budget and charter school hearings (approximately 3-6 hours during the evening)
- Attend Finance and issue briefings (approximately 4 hours per month during the daytime)
- Prepare for meetings (approximately 5 hours per month of reading)
- Attend weekly school visits (approximately 3 hours each)
- Attend community meetings (regularly throughout the year)
- 6. Additionally, Board members are subject to great public scrutiny and criticism.
- 7. Under the Charter, the Panel is charged with providing qualified candidates for the Mayor to consider for appointment to the Board. In addition to the eligibility requirements in the Charter and in state law, the Panel is expected to look for potential Board members who have a commitment to education and ensuring that Philadelphia has quality schools in every neighborhood; understand the challenges of urban education; collaborate with colleagues and stakeholders; are able to deal with conflict; have demonstrated integrity; are dedicated to all aspects of diversity and inclusion; have previously attended a Philadelphia District-run or public charter school and/or has (or had) a child attend a District-run or public charter school; and reflect the diversity of the City of Philadelphia.
- 8. The Panel's work is done on a very short time-frame. The Charter requires that once convened by the Mayor, the Panel must within forty (40) days provide three (3) candidates for each vacancy for the Mayor's consideration. The Mayor then has ten (10) days to days to ask the Panel to provide additional names which, if requested, the Panel must provide within another ten (10) days.
- 9. When the School District of Philadelphia first returned to local control in 2018, after being governed by School Reform Commission since 2001, there was a great deal of community and media interest and the Panel received approximately 600 applications for the nine (9) available new Board positions.
- 10. Since that time, however, the Panel has increasingly had a challenging time soliciting a large enough pool of qualified applicants.
- 11. For example, for the most-recent round of vacancies, the Panel had forty days to identify three (3) candidates for each of 2 vacant positions (i.e., at least 6 individuals

total – with the potential of needing to identify an additional three (3) candidates if the Mayor requested additional names). The Panel at first set a twenty-one (21) day window to receive applications for one open position in order to give the Panel time to consider the applications, conduct interviews, and finalize its recommendations to the Mayor. However, by Day 14, the Panel had only received 8 applications. At that point, and after learning that there was a second vacancy that needed to be filled, the Panel decided to extend the application window for a total of 28 days in the hopes that news of the second vacancy would bring additional interest. Ultimately 63 applications were received – but the panel had a very short time period to conclude its work.

- 12. Requiring the disclosure of *unsuccessful* applications will make it even more challenging to attract a sufficient number of qualified candidates.
- 13. A prospective applicant may find it personally or professionally embarrassing for the public to know that they applied and were not selected.
- 14. It may also be uncomfortable for applicants to have their personal statements and professional qualifications published especially since these statements often relate to their children's or their own primary and secondary school experiences.
- 15. I am aware that some unsuccessful candidates have specifically indicated they will not apply to positions of this nature if their names or unsuccessful applications are made public.

Affidavit of Feige Grundman, Divisional Deputy City Solicitor City of Philadelphia Law Department Right-to-Know Group

My name is Feige Grundman, and as the Divisional Deputy City Solicitor working in the Right-to-Know Group in the Legislation and Legal Counsel Unit of the City of Philadelphia Law Department (Law Department), I am authorized to execute this affidavit. I also serve as the Open Records Officer for the Law Department. I state the following to the best of my knowledge, information, and belief under penalty of perjury pursuant to 18 Pa.C.S. § 4904 relating to unsworn falsification to authorities:

- 1. As Open Records Officer for the Law Department and as Divisional Deputy City Solicitor working in the Right-to-Know Division in the Legislation and Legal Counsel Unit of the Law Department, I am familiar with the request at issue in this appeal seeking "all submitted Board of Education 'interest forms' submitted by individuals applying to be Board of Education appointees between the dates of 9/1/2020 and 12/8/2020" (the Request).
- 2. During the course of the Nat Lownes' (Requester's) appeal of the Request to the Office of Open Records (OOR), I personally reached out to the approximately 80 applicants who submitted Statements of Interest to the City because they wanted to volunteer on the Board of Education to let them know that an appeal had been filed, their personal information may be disclosed, and they had a right to participate in the appeal.
- 3. These applicants were, by and large, members of the public, and many did not understand my outreach or what participating in the appeal with the OOR meant.
- 4. The overwhelmingly large majority of these individuals are not attorneys, and the Law Department was not able to provide legal representation to them in this process.

- 5. Many of those who wanted to participate had technical problems filling out the forms.
- 6. Others filled out the forms but did not understand that they needed to include a statement explaining their concerns if they did not want their information to be disclosed.
- 7. Some individuals said they wanted to participate or were concerned with release, but did not provide the appropriate forms.
- 8. Other individuals did not want their identity released to OOR or to the requester.
- 9. At least one unsuccessful candidate, whose name and materials are sought by the request at issue in this appeal, was not comfortable identifying themselves in writing, but called me to tell me they would have had to quit their job if they were selected to serve as a Board member because of the state law prohibitions on appointing individuals who hold certain incompatible offices. This unnamed unsuccessful candidate has indicated that while they were prepared to resign if selected, they did not inform their employer of the application or the fact that they were willing to resign, and they fear job repercussions if that were to become public.
- 10. At least another 10—if not more—applicants expressed concern with the release of their information, , but did not want to or did not (or could not) take the steps necessary to participate in the appeal.
- 11. While the Right to Know Law does not require the City to reach out to requesters, OOR policy requires the City to provide notice to the requesters and coordinate their responses for submission to the OOR.
- 12. I sent electronic notice to the emails addresses the City had on file for these hopeful applicants, but I cannot have any level of confidence that those that did not respond received the outreach.
- 13. This was an exceptionally burdensome process during a time when the City was particularly short-staffed and dealing with numerous challenges across the City due to the pandemic and a City-wide hiring freeze with few exceptions.
- 14. I tried to help troubleshoot the issues the applicants were having with technological problems and questions about submitting an OOR statement of interest, but there was not much I could do to help if the requesters were unable to fill out the form, stopped responding when they had trouble filling it out, or submitted the form but did so incorrectly.

- 15. I have no doubt many more of the applicants I contacted wanted to participate and object to the release of their information but were unable to do so either because of a lack of understanding of the proceedings, time limitations, and/or technological challenges.
- 16. Still others didn't want their identity released, and submission of the requests to participate necessarily involved disclosing their identity to the requester and to OOR.

Appellant, the City of Philadelphia, by and through its undersigned counsel, hereby moves to supplement the record in the above-captioned appeal and avers as follows:

I. INTRODUCTION

The matter before this court is the Appellant's Motion to Supplement the Record.

II. STATEMENT OF THE QUESTION

1. Whether this Court should grant the instant Motion to Supplement the Record with an additional affidavit concerning the public interest in maintaining the confidentiality of unsuccessful applications to volunteer for the City submitted by dozens of private City residents, and to demonstrate records that were released during the course of the instant appeal?

Suggested Answer: Yes

III. BRIEF STATEMENT OF RELEVANT FACTS AND PROCEDURAL HISTORY

In the instant matter, the City has appealed the December 3, 2021 Final Determination of the Office of Open Records (OOR) in *Lownes v. City of Philadelphia, Mayor's Office*, OOR Dkt. AP 2019-1981 granting, in large part, Appellee Mr. Lownes' (Appellee) appeal seeking "all submitted Board of Education "interest forms" submitted by individuals applying to be Board of Education appointees between the dates of 9/1/2020 and 12/8/2020)" (the Request). The City refers to these forms, which include cover letters, resumes and curriculum vitaes as "Statements of Interest" or more generally as applications.

At issue is the identities, resumes, curriculum vitaes, financial information, and very personal statements of dozens of private residents of Philadelphia who applied, unsuccessfully, to volunteer for the Board of Education. The request for these sensitive records were a matter of first impression for the City as well as OOR and implicate novel issues of law.

Additionally, the Request came in during the midst of the ongoing COVID-19 pandemic at a time when the City was particularly short staffed, as described in the Affidavit of Feige Grundman, Divisional Deputy City Solicitor of the Law Department's Right to Know Division in her affidavit that is part of the Supplemental Record the City seeks to file. Exhibit A, S.R. at 035, at ¶13. Ms. Grundman further explains that the applicants whose records were at issue were confused about the process of participating in the OOR appeal, many ran into technical problems, and many that indicated they wanted to participate did not end up submitting the proper paperwork. Exhibit A, S.R. at 034-35, at ¶¶ 2-12.

The OOR's Final Determination recognized the confusion experienced by the applicants but nevertheless ordered the disclosure of their personal information with limited redactions.

Certified Record, *Philadelphia v. Lownes*, No. 220100090, Phila. CCP (Filed May 2, 2022 by OOR) (C.R.) at 199-201, 212.

On January 3, 2022, the City timely filed the instant appeal of the OOR's Final Determination.

IV. ARGUMENT

The Supreme Court of Pennsylvania has held that courts hearing appeals from the OOR have the "have the authority to expand their record to fulfill their statutory role" as fact finders. *Bowling v. Office of Open Records*, No. 20 MAP 2011, 2013 WL 4436219 (Pa. Aug. 20, 2013). Moreover, the Commonwealth Court has specifically and repeatedly held that agencies may meet their burden of proof in Right to Know Matters through the submission of affidavits. *See, e.g.*, *Hodges v. Pa. Dep't of Health*, 29 A.3d 1190, 1192 (Pa. Commw. 2011) ("[A]n agency may satisfy its burden of proof that it does not possess a requested record with either an unsworn attestation by the person who searched for the record or a sworn affidavit of nonexistence of the record."); *accord McGowan v. Pennsylvania Dep't of Env't Prot.*, 103 A.3d 374, 382–83 (Pa. Commw. Ct. 2014) (holding that in the absence of bad faith "averments in the [City's] affidavits should be accepted as true").

Before the OOR, however, local agencies have an extremely limited timeframe to submit evidence. While the City was able to obtain additional time in the course of this appeal beyond the initial seven business day time period OOR provides for responding to an appeal — the time remained extremely limited (less than a month) and was during the midst of a global pandemic and when the City was exceptionally short staffed. C.R. at 001 (noting that the appeal was filed on February 3, 2021 and the City's submission was filed on February 24, 2021). Indeed, the Courts have repeatedly recognized that the "efficiency" of the RTKL process "results in

informality bordering on lack of due process." *See, e.g., Levy v. Senate of Pennsylvania*, 65 A.3d 361, 382 (2013).

At issue in the instant appeal is whether the OOR improperly held that the detailed biographical and professional profiles of dozens of private Philadelphia residents who sought to volunteer for the City are subject to public disclosure. As third-party interests are involved supplementation of the record is particularly appropriate. Cf. Pennsylvania State Police v. *Grove*, 119 A.3d 1102, 1110 (Pa. Commw. Ct. 2015), aff'd in part, rev'd in part on other grounds, 161 A.3d 877 (2017) (holding that ground of denial was properly raised for the first time on appeal to Commonwealth Court because "[a]n agency . . . cannot waive third parties' privacy rights"); see also Pennsylvania State Educ. Ass'n v. Commonwealth Dep't of Cmty. & Econ. Dev., 148 A.3d 142, 158 (2016) ("nothing in the RTKL suggests that it was ever intended to be used as a tool to procure personal information about private citizens"). Additionally, in the course of the instant appeal, the City disclosed the Statements of Interest of those candidates that were ultimately appointed to the Board, as a result a portion of the appeal is now moot. Exhibit A, S.R. 4-33. The information in those applications also provides this Court additional insight into the type of confidential information that is at stake for the unsuccessful candidates whose records the City was ordered to release.

The City's supplementation of the record will allow the City clarify the public interest in maintaining the confidentiality of unsuccessful applicants' to the volunteer role on Board of Education, better contextualize the outreach process to unsuccessful applicants and concerns such applicants raised in the process, and provide information on the records that were released while this appeal was pending. *See* Exhibit A. The City has relied on the supplemental affidavit

in its briefing before this Court and the supplemental affidavits and records will provide the

Court additional factual background that will be helpful in making its determination.

For the reasons discussed above, supplementation of the record is necessary to clarify the

factual issues discussed above and provide information necessary to eliminate any confusion

caused by the OOR's Final Determination.

V. RELIEF REQUESTED

For the foregoing reasons, the City respectfully requests that the Court grant the City's

Motion to Supplement the Record with the supplemental record attached as Exhibit A to the
