Dear Ms. Mutchler,

I am appealing the enclosed partial denial dated May 4, 2009 from Northumberland County (herein "County") who responded to my April 29, 2009 Right-to-Know request. The agency's entire response is included.

FRAMING OF THE ISSUE FOR OOR APPEAL DETERMINATION

The County only satisfied three of the four requests for records that I had made in my Right-to-Know request dated April 29, 2009. The County ignored my request to be sent records evidencing the home address of every fair share feepayer working for the County. Because we are now past the five business day time period for a response to that item, it is deemed denied. I am challenging the County's denial of those home addresses.

Furthermore, although I agree to pay the appropriate costs for copying and postage charges, I am challenging the agency's invoice of \$10.81. As seen, the County wishes to charge me \$0.50 per page for copy costs - which is not allowed.

I respectfully ask OOR to rule that the County must release records evidencing the home addresses of the fair share feepayers, and that the County must amend its invoice to comply with the fee limitations section of the law.

For the purposes of this request "Fair share feepayer" shall have the same meaning as the definition of "Nonmember" in Pennsylvania's Fair Share Fee Law for County employees, Act 15 of 1993.

For the purposes of this request "Bargaining Unit" shall mean the shall mean any union that represents any group of employees of the County for purposes of collective bargaining pursuant to the act of July 23, 1970 (P.L. 563, No. 195), known as the "Public Employee Relations Act."

For the purposes of this request "Fair Share Agreement" shall mean any collective bargaining agreement between the County and any Bargaining Unit that requires fair share feepayers to pay a fair share fee in accordance with Pennsylvania's Fair Share Fee Law for County employees, Act 15 of 1993.

For the purposes of this request "Record" is defined as any document, e-mail, letter, correspondence, spreadsheet, communication, information, or tax form in the possession or constructive position of the County, including records prepared by any and all Bargaining Units that are required to submit information to the County pursuant to Section 4(A) of Act 15 of 1993, which reads:

"To implement fair share agreements in accordance with section 3, the exclusive representative shall provide the public employer with the name of each nonmember who is obligated to pay a fair share fee, the amount of the fee that he is obligated to pay and a reasonable schedule for deducting the amount from the salary or wages of the nonmember. The public employer shall deduct the fee in accordance with the schedule and promptly transmit the amount deducted to the exclusive representative."

If the County has a Fair Share Agreement with any Bargaining Unit, then pursuant to Act 15 the County is mandated by law to know the names of all fair share feepayers in order to perform the mandated payroll deduction of those employees' fair share fees. It is further understood that County employees' home addresses exist in human resource or payroll records, and are also recorded on tax forms such as W-2s that are sent by the County to employees.

I hereby request copies of Records that evidence the following:

- 1. The names of all fair share feepayers currently employed by the County.
- 2. The name of the Bargaining Unit that represents each fair share feepayer working for the County.
- 3. The County email address of each fair share feepayer working for the County.
- 4. The home address of each fair share feepayer working for the County.

If any of the requested information in #1 - #4 exists on multiple records, please do not send me multiple records showing the same information. Fulfilling the substance of my request is more important than any particular format in which the information is released to me.

Please know that although the County is under no obligation to collate the requested information in #1 - #4 in any particular way, there is no prohibition against doing so. I have no problem with my request being filled in a way that is least burdensome administratively to the County.

For example, if the County wanted to send me a spreadsheet containing the information requested in #1 - #4 via email to scampbell@stopteacherstrikes.org to fulfill my request, I would consider this Right-to-Know request to be fully satisfied.

I would appreciate my request being filled via email if possible to avoid the creation of paperwork.

If the County does not possess any records showing the names of the fair share feepayers because the County does not have any Fair Share Agreement with any Bargaining Unit, please provide a sworn written attestation of such a claim. Please see 'Sample Oath or Affirmation Form' on the Office of Open Records website http://openrecords.state.pa.us.

Thank you for writing to the Office of Open Records regarding the Right-to-Know law, 65 P.S. §§67.101, ("RTKL"). The OOR has received an appeal on May 18, 2009. This letter will explain our process and provide the Agency a copy of the appeal.

The OOR will assign an Appeals Officer to review the case. If all procedural requirements have been met the Appeals Officer will review the file, consult with agency counsel as appropriate, seek any necessary additional information and issue a Final Determination. The Appeals Officer may conduct a hearing, but that decision is non-appealable. If all procedural requirements have not been met the parties will receive a letter stating why the appeal has not been accepted and that no further action is needed.

If additional information is necessary to reach a Final Determination, the Appeals Officer will ask for it in writing with a deadline for submission. If either party would like to submit unsolicited information they must do so within seven (7) business days from the date of this letter and provide a copy to the opposing party. Agencies are reminded that the burden of proof rests with them in citing the exception, law, regulation, judicial order or privilege to deny a request.

I am writing in regard to *Campbell v. Northumberland County* referenced above. I have reviewed the appeal Mr. Campbell filed with the Office of Open Records ("OOR") under the Right-To-Know Law, 65 P.S. §§67.101 *et seq.* ("RTKL"), regarding the denial of addresses of fair share fee payers working for the County.

In his appeal, Mr. Campbell objects to the County's failure to respond to this request. Please be advised that failure to respond to a right-to-know request is considered a denial. If upon review of the RTKL and the relevant Final Determinations issued by this office, you still intend to deny Mr. Campbell's request please provide this office with any and all legal and factual grounds in support of your denial. To the extent you rely on facts not of record, please submit them via sworn statement or other documentary evidence as the agency bears the burden of proving its exception by a preponderance of the evidence.

In addition, Mr. Campbell is objecting to the fees charged by the County. According to the invoice that Mr. Campbell provided to us, it appears that the County is charging \$0.50 per page for copies. Under the RTKL, the OOR is charged with setting copying fees. Currently, this office provides that the maximum per page charge for copies that an agency is permitted to charge is \$0.25.
