



FINAL DETERMINATION

IN RE *Aaron Shover v. Big Spring School District*;

Upon review of the appeals filed with the Office of Open Records (“OOR”) to the above-referenced docket numbers, it is determined that the appeals are **DISMISSED** because:

The appeals are premature. The Requests were received by Big Spring School District (“District”) on May 27, 2026, and the District invoked a thirty-day extension of time to respond on June 3, 2026. 65 P.S. § 67.902(b)(1). The extensions were invoked for a permitted reason and meet the statutory requirements for a valid extension, 65 P.S. § 67.902(a)(1, 3, 4, 7), and the OOR will not disturb the District’s discretion in invoking the extensions. 65 P.S. § 67.902(b)(1). Under the extensions, the District has five (5) business days, followed by thirty (30) calendar days, from May 27, 2026 to respond to the Requests, or until July 6, 2026.¹ 65 P.S. §§ 67.902(b)(1)-(2). The appeals were submitted to the OOR on June 17, 2026, before the District’s time to respond had elapsed. The Requester is not prohibited from filing a new appeal(s) to the OOR of any denial or deemed denial stemming from the Requests, pursuant to the requirements of 65 P.S. § 67.1101(a)(1).

For this reason, the District is not required to take any further action. Within thirty days of the mailing date of this Final Determination, you may appeal or petition for review with the Cumberland County Court of Common Pleas. 65 P.S. § 67.1302(a). All parties must be served with notice of the appeal. The OOR also shall be served notice and have an opportunity to respond according to court rules as per 65 P.S. § 67.1303. However, as the quasi-judicial tribunal adjudicating this matter, the OOR is not a proper party to any appeal and should not be named as a party.² All documents or communications following the issuance of this Final Determination shall be sent to oor-postfd@pa.gov.
