**FINAL DETERMINATION** 

AND NOW, the Northampton County District Attorney's Office respectfully submits its Final Determination as to Lawrence Peterson's ("Requester's") Right to Know Law ("RTKL") request.

#### Introduction

Upon information and belief, on September 8, 2023, the Northampton County District Attorney's Office ("Respondent") received a request from Requester seeking (1) a copy of a Mental Health Examination dated March 20, 2000, and (2) and 'Post sentence investigation (PSI) report dated July 17, 2000. See Exhibit "A". On September 14, 2023, Respondent denied the request as a record of an agency relating to or resulting in a criminal investigation (Section 708(b)(16) of the RTKL, 65 P.S. § 67.708(b)(16)) and The Criminal History Records Information Act (CHRIA, 18 Pa.C.S.A. §9106(c)(4)). See Exhibit "B." This response was returned for lack of an inmate number and court control number on or about September 23, 2023, which identifiers were not contained on the request (Exhibit A). See Exhibit "C."

On October 12, 2023, an appeal, forwarded by the Pennsylvania Office of Open Records, was received by the Northampton County District Attorney's Office Appeals Officer. *See* Exhibit

"D." The appeal specifically requested all materials denied by Respondent. This document is the Appeals Officer's final determination regarding the items denied by the Respondent.

#### Discussion

In this case, Requester seeks information, which the undersigned believes relates to Docket No.: CP-48-CR-0000493-1999. *See* Exhibit A. The records Requester seeks relate to a criminal investigation, and thus are exempt from access by the Requester under the RTKL. A public record is "[a] record in the possession of a Commonwealth agency or local agency shall be presumed to be a public record. The presumption shall not apply if (1) the record is exempt under section 708. ..." 65 P.S. §67.305(a)(1). The burden is on the responding agency to show by a preponderance of the evidence that the record is exempt from public disclosure. 65 P.S. §67.708(a)(1).

The Northampton County District Attorney's Office Appeals Officer retains authority to determine whether a request under the RTKL seeks records related to a criminal investigation. 65 P.S. §67.503(d)(2). Under section 708(b)(16), "[a] record of an agency relating to or resulting in a criminal investigation" is exempt from disclosure. 65 P.S. §67.708(b)(16). This includes "[a] record that includes information made confidential by law or court order." 65 P.S. §67.708(b)(16)(iv). "All pre-sentence reports and related psychiatric and psychological reports shall be confidential, and not of public record." 234 Pa.Code Rule 703(A).

Additionally, CHRIA prohibits the disclosure of the information requested. This information is "investigative and treatment information" which is defined by CHRIA as: "[I]nformation assembled as a result of the performance of any inquiry, formal or informal, into a criminal incident or an allegation of criminal wrongdoing and may include *modus operandi* information." 18 Pa.C.S.A. § 9102. Importantly, 18 Pa.C.S.A. § 9106(c)(4) specifies that: "Investigative and treatment information shall not be disseminated to any department, agency or

individual unless the department, agency or individual requesting the information is a criminal justice agency which requests the information in connection with its duties, and the request is based upon a name, fingerprints, *modus operandi*, genetic typing, voice print or other identifying characteristic." The Requester is not a "criminal justice agency" as defined by 18 Pa.C.S.A. § 9102. Therefore, the requested information cannot be disseminated to the Requester under CHRIA.

Here, the record at issue is, on its face, related to a criminal investigation, treatment information, and confidential, and is exempt from disclosure under the RTKL and CHRIA.<sup>1</sup>

#### Conclusion

For the foregoing reasons, Requester's request is **DENIED**. This Final Determination is binding on the parties. Requester may file a petition for judicial review in the Northampton County Court of Common Pleas within 30 days. 65 P.S. § 67.1302.

Please be advised that this office acknowledges receipt of your mailed request dated received September 8, 2023, which requested copies certain records pursuant to the Pa. RTKL, which sets forth which records are subject to public access. The records you requested under the RTKL were:

- 1) Mental Health Examination on date 3-30-2000
- 2) Post sentence investigation (PSI) report on 7-17-2000

Please be advised that the request for the records must be denied. This office relies on Section 708 of the Right to Know Law, which provides that certain records are subject to an exemption for disclosure as follows:

... (16) A record of an agency relating to or resulting in a criminal investigation, including: (i) Complaints of potential criminal conduct other than a private criminal complaint. (ii)Investigative materials, notes, correspondences, videos, and reports. ...(vi) A record that, if disclosed, would do any of the following: endanger the life or physical safety of an individual.

The information you request involves a criminal investigation. As such, it is exempt from disclosure. See *Coley v. Philadelphia District Attorney's Office*, 77 A.3d 694, 696 (Pa. Commw. 2013) (denying access to investigative materials because criminal investigation records are still exempt after investigation is completed). To the extent that your requests asks for documents that are not police blotters, it is denied.

Additionally the Criminal History Record Information Act 18 Pa.C.S. § 9106(c)(4) states that "investigative and treatment information shall not be disseminated to any department, agency or individual unless the department, agency, or individual requesting the information is a criminal justice agency." Investigative information is "information assembled as a result of the performance of any inquiry, formal or informal, into a criminal incident or allegation of criminal wrongdoing and may include modus operandi information." 18 Pa.C.S. § 9102. The information you have requested is "investigative information" and you are not a criminal justice agency, so the information you requested cannot be released under the RTLK. In fact, the District Attorney's office would have been legally prohibited from releasing that information under the RTLK due to CHRIA.
